SUBJECT: Action regarding recommendation from Beautification Committee to approve a proposal from Peterson's Landscape and Maintenance Services to replace the existing landscape border at the Welcome/Entry Sign (intersection of Longhorn/Industrial and Saginaw Boulevard)

BACKGROUND/DISCUSSION:

Due to age and vibration from the train and vehicle traffic, the landscape border in front of the welcome/entry sign has fallen. The Beautification Committee discussed repairing the border. At their meeting on October 3, 2016, they voted to recommend approval of the proposal from Peterson's Landscape and Maintenance Services to replace the border at a cost of \$990.

FINANCIAL IMPACT:

The financial impact will be \$990.00. Funds are available in the Beautification Donation Fund to cover this expenditure.

RECOMMENDATION:

The Beautification Committee recommends approval of the proposal from Peterson's Landscape and Maintenance Services to replace the existing landscape border at the Welcome/Entry Sign (intersection of Longhorn/Industrial and Saginaw Boulevard) at a cost of \$990.00.

ITEM:

Consideration and action to approve funds for Saginaw Beautification Landscaping Project

PRESENTER:

Keith C. Rinehart, Director of Recreation & Community Services

DISCUSSION:

One year ago, the City Council approved funding for the Beautification Committee to install a new Welcome/Entry Sign at the intersection of Longhorn/Industrial and Business 287. Over time the landscape border in front of the new entry sign has fallen due to age and vibrations from the nearby train tracks and Business 287 road.

Several months ago, the Beautification Committee discussed repairing the fallen landscape border and asked staff to investigate costs. At the October 3, 2016 Beautification Meeting, the Committee approved funding of \$990 for Peterson's Landscape & Maintenance Services to remove the existing landscape border and install a new one. It will have a deep concrete base and the border will be made of sandstone to match the Entry Sign.

RECOMMENDATION:

The Beautification Committee and Staff are recommending the approval of \$990.00 for Peterson's Landscaping to remove the existing fallen landscape border and install a sandstone border at the location near the entry sign at Longhorn/Industrial and Business 287.
