CITY OF SAGINAW RESOLUTION NO. 2018-14

A RESOLUTION OF THE CITY OF SAGINAW, TEXAS, CANVASSING RETURNS AND DECLARING RESULTS OF AN ELECTION HELD IN THE CITY OF SAGINAW ON MAY 5, 2018 FOR THE PURPOSE OF ELECTING MAYOR AND COUNCILMEMBER PLACE 2; FINDING THAT NO MAJORITY OF VOTES WAS CAST TO FILL THE UNEXPIRED TERM OF COUNCILMEMBER PLACE 4 AND THAT A RUNOFF IS NECESSARY.

WHEREAS, on May 5, 2018, a general election was held for the offices of Mayor and Councilmember Place 2 and a special election was held for the purpose of filling the unexpired term of the office of Councilmember Place 4; and

WHEREAS, said election was duly held at the time and place specified, after due notice as required by law had been given by posting and publication; and

WHEREAS, there were 29 electors voting at said election, who cast votes as follows:

FOR MAYOR

TODD FLIPPO 363 Votes

FOR COUNCILMEMBER PLACE NO. 2

Patrick Farr 241 Votes
Randy Villarreal 121 Votes
Mel. A. Aguilar 54 Votes

FOR COUNCILMEMBER PLACE NO. 4 (UNEXPIRED TERM)

Steve Collier 99 Votes Chris Carter 118 Votes Charlie Tucker 195 Votes

as is reflected by the election returns heretofore filed by the election judges with the City Secretary; and

WHEREAS, only qualified voters of the City of Saginaw, Texas, were allowed to vote in said election.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAGINAW, TEXAS:

1. That said election was duly called; that notice of said election was given in accordance with law and the resolution calling the election; that the election was held in accordance with law; that due return of said election has been made by the proper officers; and that the qualified voters of the City of Saginaw, Texas, voting in said election have duly elected Todd Flippo as Mayor and Patrick Farr as Councilmember Place No. 2. There being no majority of votes for the position of Councilmember Place 4, and the two candidates receiving the highest and second highest number of votes and who shall be candidates in a runoff election on June 16, 2018, are as follows:

Chris Carter Charlie Tucker

- 2. That the said Todd Flippo is hereby declared duly elected to the office of Mayor of the City of Saginaw, Texas.
- 3. That the said Patrick Farr is hereby declared duly elected to the office of Councilmember Place No. 2, of the City of Saginaw, Texas.
- 5. That the proper officials are hereby authorized to administer oaths of office and do all things necessary to install said officers in their respective offices.
