**A RESOLUTION OF THE CITY OF SAGINAW, TEXAS, CANVASSING RETURNS AND DECLARING RESULTS OF A RUN-OFF ELECTION HELD IN THE CITY OF SAGINAW ON JUNE 16, 2018 FOR THE PURPOSE OF ELECTING COUNCILMEMBER PLACE 4.**

WHEREAS, on May 5, 2018, a special election was held in the City of Saginaw for the purpose of filling the unexpired term of City Councilmember Place 4; and

WHEREAS, no candidate in said special election received the votes necessary to be elected to the office of City Councilmember Place 4; and

WHEREAS, on May 15, 2018, the City Council of the City of Saginaw, Texas adopted Resolution number 2018-15 calling a run-off election to be held in the City on June 16, 2018 for the purpose of electing Councilmember Place 4; and

WHEREAS, said election was duly held at the time and place specified, after due notice as required by law had been given by posting and publication; and

WHEREAS, only qualified voters of the City of Saginaw, Texas, were allowed to vote in said election; and

WHEREAS, there were 229 electors voting at said election, who cast votes as follows:

**FOR COUNCILMEMBER PLACE NO. 4**

Charlie Tucker	179 Votes
Chris Carter	50 Votes

as is reflected by the election returns heretofore filed by the election judges with the City Secretary; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAGINAW, TEXAS:

1. That said election was duly called; that notice of said election was given in accordance with law and the resolution calling the election; that the election was held in accordance with law; that due return of said election has been made by the proper officers; and that the qualified voters of the City of Saginaw, Texas, voting in said election have duly elected Charlie Tucker as Councilmember Place No. 4.
2. That the said Charlie Tucker is hereby declared duly elected to the office of Councilmember Place No. 4, of the City of Saginaw, Texas.

3. That the proper officials are hereby authorized to administer oaths of office and do all things necessary to install said officers in their respective offices.
