BACKGROUND/DISCUSSION:

This proposed Interlocal Agreement with the Fort Worth Transportation Authority (“Trinity Metro”) is related to Item 4d. This additional agreement addresses an additional day of guaranteed service for the elderly and persons with disabilities. There will be no additional costs to the City because Trinity Metro was awarded a grant that will cover the additional day. The additional guaranteed day in Saginaw will be Wednesday. Approval of this agreement will give the elderly and persons with disabilities a total of two guaranteed days each week (Monday and Wednesday) for transportation services. On the remaining days of the week, rides are available subject to the priority requests from other cities on a first-come basis.

FINANCIAL IMPACT:

The cost of the additional day will be paid for by a grant received by Trinity Metro.
