A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAGINAW, TEXAS, PROVIDING PUBLIC HEARING COMMENTS TO THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE FM 156 (BLUE MOUND ROAD) RECONSTRUCTION AND WIDENING PROJECT.

EXHIBIT "A"

City of Saginaw Comments for the FM 156 (Blue Mound Road) Reconstruction and Widening Project.

- 1. There is a notation on the schematic on Bailey Boswell Road west of FM 156 indicating that the City of Saginaw is responsible for funding that portion of the project. The City of Saginaw has not agreed to fund any portion of this project and need clarification of the notation's meaning.
- 2. Traffic Noise Technical Report. The Public Hearing schematic depicted a sound wall on the east side of the roadway south of Bailey Boswell. The report recommended three additional walls (2, 4-1, 4-2 and 4-3) on the west side. The report noted difficulties with clearances and recommended that the walls be eliminated or that the project be delayed to allow for additional right-of-way needed to accommodate the walls. The City of Saginaw requests that adverse noise impacts to its citizens be mitigated and that they receive equal treatment with those areas east of the roadway.
- 3. Median Opening. The City of Saginaw desires a median opening south of Bailey Boswell Road to allow north bound access to the tract at the southwest corner of FM 156 and Bailey Boswell. The city has had development interest in the tract and the access will allow addition ingress/egress.
 - **4.** The lane geometry for the extension of Bailey Boswell east of FM 156 needs to be detailed since the schematic shows dual lefts on Bailey Boswell going eastbound.
